### **Stamford Grand Adelaide**

Located 10kms from the heart of Adelaide city, Glenelg is a charming seaside resort set on the long, sandy, white shores of Holdfast Bay. With seven-day shopping, museums, galleries, restaurants and cafés it is the ideal conference location.

Located on absolute beachfront the Stamford Grand is one of Australia's leading resort style hotels with newly designed rooms which are sleek and contemporary in style.

The tariff is \$205.00 per room per night including GST for single, double or twin occupancy. All single/double rooms contain one king size bed or two double beds and twin rooms have two double beds. If a rollaway bed or cot is required please contact MIE Management. Rollaway beds are \$38.00 per night and cannot be put into twin rooms. There is no charge for a cot. ### **CLE/CPD/CPE Accreditation**

The Victorian Bar CLE Accreditation and Dispensation Committee has resolved to accredit members of the Victorian Bar with 1 CLE point per hour of attendance to a maximum of 5 CLE points for attendance at the entire conference.
