Dear Member,

The Annual General Meeting of our Society will be held on Saturday, 20 September 2008 at 1.30 p.m. at the Stamford Grand Adelaide, Moseley Square Glenelg, South Australia, Australia.

The Rules of the Society require that nominations for officers of the Society and for ordinary members must be sought two months before the Annual General Meeting and that such nominations must be received by the Secretariat one month before the Annual General Meeting.

Transmission by post, facsimile or email is acceptable. However, members are advised to allow adequate time for postal delivery and transmission by facsimile is recommended if the deadline is close.

Our rules provide that the Trans-Tasman National Committee shall consist of the Officers of the Society and 8 to 15 ordinary members as well as the Chairpersons of each of the Local Organisations. A person may be nominated as an Officer as well as an ordinary member but if elected as an Officer will not then be a candidate as an ordinary member. The rules also provide that an Officer shall not hold the same office for more than three consecutive years. Please note that two nominators are required for each nominee.

All members are reminded that they must have paid their subscription for 2008/2009 to nominate, stand for office, or vote at the Annual General Meeting.

It is important **to note** that these elections are for the **Trans-Tasman National Committee**. Nominations and elections for the committees of the various Local Organisations will be organised by the **Local Organisations at a later date**.
