The High Court's pending decision in this litigation, will be highly significant for Australian copyright law and the extent to which compilations of information can legitimately be protected by copyright.

Julian Cooke has appeared as counsel in this case and will present his insights and views on this highly significant copyright litigation.

Julian Cooke is a barrister who practices in the field of intellectual property law. As well as appearing in the Federal Court and in the High Court in IceTV Pty Ltd v Nine Network Australia Pty Ltd he has appeared in a wide variety of IP cases in the Federal Court, including The Polo/Lauren Company LP v Ziliani (copyright and designs), Alphapharm Pty Ltd v H. Lundbeck A/S (patent), Apotex Pty Ltd & Spirit Pharmaceuticals Pty Ltd v Sanofi-Aventis (patent), Health World Ltd v Shin-Sun Australia Pty Ltd (trade marks).

Julian was born in Perth and holds degrees from Murdoch University and the University of Oxford. He now lives in Sydney and practises from 10th Floor Selborne/Wentworth Chambers.
