**Programme:**

IPSANZ are pleased to bring to delegates a wonderful and varied programme that includes high profile speakers both locally and internationally. **Table Topic Sessions**

We have introduced for the first time a Table Topic Session. It will run on Friday between 3-5pm prior to the official opening of the Conference.

The Table Topic Sessions will consist of ten tables with a facilitator/s. They will introduce a topic for the member's participation. These sessions will allow practitioners to participate in a lively round table discussion, the format having an interactive networking aspect with topics selected to be of current interest. It is likely that these sessions will stimulate a lively debate as well as allow delegates to meet a number of other like-minded people prior to the conference.

Specially invited and selected senior practitioners and in-house corporate counsel will facilitate discussion at each table. The aim is to encourage open discussion and slightly more overt networking. Background knowledge or experience within areas for discussion is not required. You will have the opportunity to discuss three or four topics: at scheduled turnover times and move around the tables to the next topic of your choosing.

**Welcome Cocktails**

Invitation is extended to delegates and accompanying persons to attend the Welcome Cocktails which are being hosted in the Blu Bar on 36. This is a New York-inspired Bar that is an attraction in its own right, that exudes urban sophistication. ### Conference Venue

The Shangri-La Hotel is located in the historic Rocks district in the heart of the dynamic city, Sydney offering stunning views of Sydney's spectacular Harbour, the Sydney Harbour Bridge and the world-famous Opera House.

IPSANZ have secured a number of Deluxe Darling Harbour and Deluxe Opera House City view rooms. These rooms are most spacious and luxurious guest rooms. All have breathtaking views and are exquisitely appointed with contemporary furnishings and signature bed linens.

Complimentary Broadband and Wifi Internet Access is provided in all guestrooms and meeting rooms.

The Shangri-La Hotel incorporates a gym with a full range of exercise and health equipment, heated indoor swimming pool and sauna. Complimentary Health Club Access is offered to delegates.

### Accommodation

All king/twin rooms contain one king size bed and twin rooms have two double beds. If a rollaway bed or cot is required please contact our Conference Organisers. There is no charge for a cot. Please note the maximum capacity for accommodation guestrooms is 3 adults or 2 adults and 2 children (12 years of age or under). Interconnecting rooms for families can be arranged and subject to availability at point of reservation, however these would attract a standard tariff on each room.

### Buffet Breakfast in Café Mix

Café Mix is Shangri-La Hotel, Sydney's all-day dining restaurant, with the focus on "fresh" and "diverse". It is located on level one of the hotel.



### Car Parking

The daily charge for the use of the Car Park is A\$47.00 per vehicle per day, which allows for one arrival and one departure. Conference car parking for day delegates is A\$38.00 per vehicle per day.

### Extra person

A sixty (A\$60.00) dollar bedding surcharge will be incurred for a rollaway bed, with a maximum of one rollaway per room. Rollaway beds are available on request, and subject to availability.

The agreed accommodation rate at the Hotel for before and/or after the conference may be available three days pre and post conference dates. Availability is limited and is subject to availability.

A pre authorisation of incidental charge of A\$100.00 per night will be required upon check-in into the Hotel. Full settlement of guest room account is required on check out of 11.00am.

### **Travel Insurance**

Travel insurance is recommended if you are travelling from overseas and should be purchased when you are arranging your air bookings.

### **Transport to The Rocks**

The Rocks is located in the CBD of Sydney and is 11km from Sydney airport. Transport options include Sydney transfer via airport express train to Circular Quay (followed by a 5 min walk to hotel) from Sydney airport; or Taxi transfer from Sydney airport is available.

### **Climate and Dress**

The weather in Sydney during the conference can be expected to range from 11°C to a maximum of 20°C during the day, mild to warm with cool evenings. Delegates are recommended to bring a jumper or jacket.

**Dress code is smart casual.**

### **CLE/CPD Accreditation**

IPSANZ have sought approval of the respective authorities governing the legal profession with respect to accreditation of its programme in order that delegates can earn points required to complete mandatory Continuing Legal Education/Continuing Professional Development.

The New South Wales Bar Association has resolved to accredit 1 point per hour to a maximum of 6 CPD points for the entire conference.

The Western Australian Legal Practice Board has resolved to accredit 1 point per hour to a maximum of 7 CPD points for the entire conference. Please contact IPSANZ for the break-down of competency areas/points.

The Bar Association of Queensland has accredited the conference with 1 CPD point per hour of attendance in the non-allocated strand, and 3 CPD points per hour of seminar presentation. Accreditation code is IPS110902.

Registered patent and/or trade marks attorneys may claim CPE hours for attendance.
