Cancellations/Refunds

Where cancellation advice is received by letter, email or fax no later than 31 July 2013, a full refund of the registration fee and accommodation will be made. CLE/CPD Accreditation

The Bar Association of Queensland has accredited the conference with 1 CPD point per hour of attendance at the educational sessions in the non-allocated strand and 3 CPD points per hour of seminar presentation. Accreditation code is IPSANZ130920.
