## Extra Person

A sixty (NZ\$60.00) dollar per night bedding surcharge will be incurred for a third adult or rollaway bed (adult or child), with a maximum of one rollaway bed per room. Rollaway beds are available on request, and subject to availability. Cots are available on request and at no charge. Additional breakfast is also available at NZ\$30.00. Please note the maximum capacity for accommodation guestrooms is 3 adults or 2 adults and 2 children (14 years of age or under). Interconnecting rooms for families can be arranged however these would attract a standard tariff on each room (as per applicable rates).

The agreed accommodation rate at the Resort for before and/or after the conference may be available five days pre and post conference dates. Availability is limited and the agreed accommodation rate pre and post conference is subject to the availability.

A pre authorisation of incidental charge of A\$100.00 per night may be required upon check-in into the Hotel. Full settlement of guest room account is required on check out (checkout time 12.00pm).

### Places of Interest: Accompanying Persons

While no formal accompanying persons programme has been arranged, there is no place like Queenstown.

Queenstown is a resort town in Otago in the south-west of New Zealand's South Island. It is built around an inlet called Queenstown Bay on Lake Wakatipu, a long thin Z-shaped lake formed by glacial processes, and has spectacular views of nearby mountains such as The Remarkables, Cecil Peak, Walter Peak and just above the town; Ben Lomond and Queenstown Hill.

Some of the many attractions include: Skiing, snowboarding, white water rafting, mountain biking and sky diving. When it comes to thrills, Queenstown is world-famous for its extreme adventure activities, from bungy jumping to jet boating. For those after something a little more sedate, a 100 year old twin screw coal fired steamer; TSS Earnslaw traverses Lake Wakatipu.

Queenstown is a major centre for snow sports in New Zealand, with people from all over the country and many parts of the world travelling to ski at the four main mountain ski fields (Cardrona Alpine Resort, Coronet Peak, The Remarkables and Treble Cone). While September is getting a little late in the season, we understand from the locals that it is likely that there should still be some good skiing opportunities.

### Transport to Hilton Queenstown Resort & Spa

Hilton Queenstown Resort & Spa is located approximately 3 km (5 minutes) from Queenstown airport and has scheduled flights from Auckland, Christchurch, Rotorua, Wellington, Sydney, Melbourne and Brisbane.
