**Topic:** De minimis: Patent infringement and relief

Tom Cordiner QC will discuss how de minimis patent infringement might affect a finding of infringement or the granting of injunctive relief. Where an alleged infringer's otherwise lawful conduct involves use of a patented product or process only a small proportion of the time, will there be an "exploitation" of the claimed invention as a matter of statutory construction, or according to a proper construction of the patent? If so, is injunctive relief appropriate and, if not, how are the interests of the patentee and infringer to be balanced?
