**Peppers Salt Resort and Spa and Mantra on Salt Beach**

The Peppers Salt Resort & Spa and Mantra on Salt Beach, Kingscliff are located 20 minutes South of the Gold Coast Airport and 40 minutes drive from Byron Bay. The resort and lagoon style pools can be enjoyed or a short stroll down to Kingscliff Beach.

#### **Peppers Salt Resort and Spa**

King bed room rate is A\$355\* (single occupancy) and 1 Bedroom Spa Suite room rate is A\$400\* (single occupancy) and a 2 Bedroom Spa Suite room rate is \$700\* (Twin occupancy) per room, per night and is **inclusive of full buffet breakfast and WIFI**.

#### **Mantra on Salt Beach**

King bed room rate is A\$305\* (single occupancy) and 1 Bedroom Spa Suite room rate is A\$355\* (single occupancy) and a 2 Bedroom Spa Suite room rate is \$650\* (Twin occupancy) per room, per night and is **inclusive of full buffet breakfast and WIFI**.

\*Accommodation is not subject to GST (Goods and Services Tax) as they are residential investments and invoices are raised on behalf of the individual owners. Subject to new Government taxes or changes to existing tax legislation (State or Federal) effecting accommodation or associated services, the Resort reserves the right to vary the prices and conditions of the contract accordingly.

#### **Accommodation Room Types**

A Hotel room contains one King size bed or 2 Single beds. Maximum occupancy is 2 guests.

1 Bedroom Suites contain one King size bed. Maximum occupancy is 3 guests, utilising existing bedding and one rollaway bed.

2 Bedroom Suites contain two King size beds or one King size bed and 2 single beds. Maximum room capacity is 5 guests, utilising existing bedding and one rollaway bed.

3 Bedroom Suites contain three King size beds or one King size bed and 4 single beds, or 2 king beds and 2 single beds. Maximum room capacity is 7 guests, utilising existing bedding and one rollaway bed.

#### **Extra Person**

For an additional person, using existing bedding and with breakfast, the rate is \$25 per night.

For an additional person in a 1 Bedroom Suite, adding a roll-away bed, and with breakfast, the rate is \$75 per night

For an additional person in a 2 Bedroom Suite, using the roll-away bed, and with breakfast, the rate is \$75 per night

#### **Children Breakfast charges**

Children 0-3 eat free, children 4 years and over pay the full rate of \$25 each.

One rollaway bed is available in the One Bedroom Suites, Two Bedroom Suites and Three Bedroom Suites.

The agreed accommodation rate at the Hotel may be available for three (3) days pre and three (3) days post the Conference nights. Availability is limited and will be subject to the Hotel's availability.

A credit card pre-authorisation of A\$200.00 or a \$200 cash bond deposit on check-in. Full settlement of guest room account is required on check out.

**Note:** A limited number of rooms are allocated to IPSANZ and accommodation at the Hotel cannot be guaranteed after these rooms have been allocated.

Check-in time is 2:00pm and check-out time is 11:00am.

A full buffet breakfast is served at the Peppers Salt Resort & Spa - Season Restaurant, from 7:00am to 10:30am daily.

Self parking is available and is undercover for all inhouse guests plus open-air parking available around salt village. Plenty of parking available.

## Transport to Peppers Salt Resort & Spa Restaurant

Peppers Salt Resort & Spa Restaurant is 20 minutes South of the Gold Coast Airport. Taxis are available at all times of the day from the front of the airport terminal. An average fare to the resort is A\$50.

## Payment

Registration and payments are processed online via a secure gateway. Payments are in Australian dollars and may be made by cheque or bank draft payable to IPSANZ or by Visa or MasterCard.

## Cancellations/Refunds

Where cancellation advice is received in writing no later than 17 July 2023, a full refund of the registration fee and accommodation fees will be made. No refunds will be made after 17 July 2023. Registrations can be transferred to a substitute delegate at no additional cost, provided the Secretariat is advised in writing in advance.

## Climate and Dress

The weather in Kingscliff during September can range from 10°C to a maximum of 23°C during the day, with cool evenings. Dress code is smart casual.

## CPD / CPE Accreditation

CPD/CPE points can be claimed for attending technical sessions.

If you are the holder of a New South Wales, Queensland, South Australian, Victorian or New Zealand Practising Certificate, you may be eligible to claim one CPD/CPE point for each hour of attendance at technical sessions.

Registered patent and/or trade marks attorneys may claim CPE hours for attendance at technical sessions.

For members with Western Australian Practising Certificates, you may be able to claim a maximum of 6 CPD points in Competency Area 4 – Substantive Law. This is subject to approval sought by you from the Western Australian Legal Practice Board.
